Additionally, the system has the ability to validate a given procedure against diagnosis for a particular situation. Various reports are available from the system that provides a list of all outstanding accounts with procedures that have no matching diagnosis.

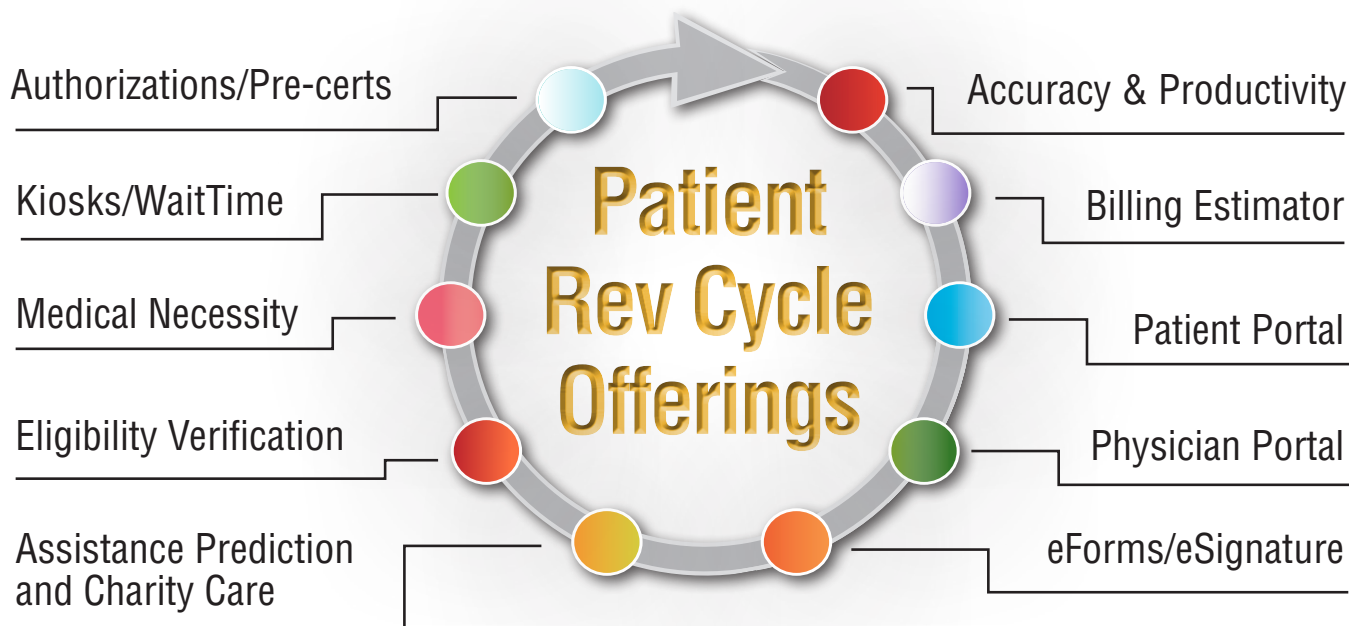
